2. Each restricted stock unit represents a contingent right to receive one share of United Technologies Corporation common stock.

3. The reporting person was also awarded 1,650 performance share units (PSUs) under the UTC Long Term Incentive Plan. Each PSU has a value equal to one share of UTC common stock. These PSUs vest solely upon achievement of pre-established performance targets for UTC's earnings per share and total shareholder return over a three year time period.
