Explanation of Responses:

- 1. The restricted stock units vest on retirement from UTC on or after age 62 with a minimum of three years of service as a member of UTC's Executive Leadership Group. Each restricted stock unit represents a contingent right to receive one share of United Technologies Corporation Common Stock.
- 2. Each Savings Restoration Plan ("SRP") stock unit is the economic equivalent of one share of UTC common stock. The reported SRP stock units were acquired under UTC's Savings Restoration Plan, an excess benefit plan, and are to be settled upon the reporting person's retirement or other termination of service.
- 3. The reporting person was also awarded 8,100 performance share units (PSUs) under the UTC Long Term Incentive Plan. Each PSU has a value equal to one share of UTC common stock. These PSUs vest solely upon achievement of pre-established performance targets for UTC's earnings per share and total shareholder return over a three year time period. 4. 50% of the stock appreciation rights become exercisable on 2/9/2015 and 50% of the stock appreciation rights become exercisable on 12/31/2016, each subject to achievement of pre-established earnings and
- other financial targets 5. The reporting person was also awarded 9,900 performance share units (PSUs) under the UTC Long Term Incentive Plan. Each PSU has a value equal to one share of UTC common stock. These PSUs vest
- solely upon achievement of pre-established performance targets for UTC's earnings per share and total shareholder return over a three year time period. 6. The reporting person was also awarded 8,200 performance share units (PSUs) under the UTC Long Term Incentive Plan. Each PSU has a value equal to one share of UTC common stock. These PSUs vest
- solely upon achievement of pre-established performance targets for UTC's earnings per share and total shareholder return over a three year time period.
